3. Who receives your information?

We work closely together with ANSE (Association of National Organisations for Supervision and Coaching in Europe) to organize and successfully run the ANSE Summer University 2023 event. For this purpose, your personal data will be transmitted to ANSE.

Any transmission of data between the Data Controller and their internal units is managed through agreed processes which comply with relevant data protection legislation.

Unless we have a legal obligation to do so, we will not disclose your data to individuals, organizations, or other entities other than those who are acting as agents and data processors working on our behalf.

For the purposes set out above, it may be our legitimate interest to pass your information to our third-party service providers and subcontractors, for the purposes of completing tasks and providing services to you on our behalf. However, with all external entities with whom data is shared, we share only those data needed to perform the specific service and require a contract and/or confidentiality and non-disclosure agreement to be signed before any data transfer—requiring them to keep your information secure and not to use it for their own purposes. We will not sell or rent your information to third parties.

Your billing details will be forwarded to our accountant and the invoice will be also forwarded to the national tax authority (NAV).
